Dear Clerk of Court,

Good day. I truly appreciate your previous timely responses and willingness to assist when I've inquired in the past.

I'm writing again to ask if there have been any **new filings, complaints, reports, or petitions** under my name, **Jordan James Peterson**, since my last request. I'd like to stay updated and properly informed of any actions or legal matters that may involve me, especially relating to my child, **Adri'el Degillo Peterson**.

I'd also like to raise a concern I believe is important. My child has now been withheld from me for **54 days**, reportedly under the action or involvement of DSWD. However, as far as I understand

under **Section 29 of RA 7610**, DSWD may only separate a child from a parent for **up to 5 days** without filing a petition with the court for continued custody. If no petition has been filed, I worry this extended withholding may be in violation of that rule.

This concern is part of why I'm trying to stay on top of any filings related to me or my child. Thank you again for taking a moment to check.
