**Subject:** Formal Request for Transparency and Access to Official Barangay Records Involving My Child Adri'el Degillo Peterson

Dear Hon. Barangay Captain,

I respectfully request access to all official Barangay records, blotter entries, meeting notes, or related communications involving the following individuals involving my name or my son's name:

- **Adri'el Degillo Peterson** (my son, a minor)
- **Anngeneth Maylan Degillo Peterson** (mother)
- **Equella Maylan Degillo (Lina)** (mother-in-law)
- **Jordan James Peterson** (father and undersigned)

This request covers all entries or actions from **January 1, 2024 to present** concerning child custody, family disputes, welfare concerns, and any coordination with the DSWD, Bacong Police, or third parties.

To aid in locating records, below is a **partial, non-exhaustive summary** of events based on documentation and real-time logs in my possession:

- In **mid-February 2025**, my child was removed from my care and concealed at an undisclosed location, without mediation, notice, or lawful authority. I was misled by Equella Maylan Degillo ("Lina") that he would return the same evening—which did not occur.
- **Moments after the removal**, I flagged down the Barangay Captain and an official passing by the Degillo residence to inform them. I was instructed to visit the Barangay Hall the next day.
- At the Hall the following day, I attempted to report the incident and request mediation regarding custody. My report was declined, and no blotter entry was recorded. The lady at the desk was unwilling to remain neutral or process the concern.
- Later that same day, I attempted to file a blotter at **Bacong Police Station**. The desk officer refused to accept my blotter, invoking the "tender-age presumption," which contradicts **Article 211 of the Family Code** (EO 209, 1987), stating both parents share joint custody, and in disagreement, the father's decision prevails absent a court ruling.
- A few days later, **three Barangay officials served a Barangay Protection Order (BPO)** at my gate based on a social media post I made seeking help in locating my son. The BPO, filed by Anngeneth Degillo Peterson, alleged psychological harm to third parties and improperly listed my son's name. Official told me mediation would follow the 15 day BPO (which to date hasn't occurred). My landlord Elena Kadusale witnessed this event. I refused to sign and stated that the public had a right to know the truth.
- In **early to mid-March 2025**, a second BPO was served indirectly through my landlord. It included accusations of non-apology and directed me to cease communications with Anngeneth regarding my son's whereabouts. My son's name was again included.
- In **mid-April 2025**, Barangay official Amildred Kidlat visited my home to inform me of a DSWD-called meeting scheduled for the following Monday at 3:00 PM. I requested written documentation identifying the case number

and purpose. I also requested a meeting with the Barangay Captain which Amildred confirmed (which to date hasn't occurred).

- At a subsequent meeting between DSWD, a Bacong Police officer, and a Barangay representative, the Barangay deferred to DSWD as “the prosecutor” and declined to acknowledge my reference to Article 211.
- Around the same time, I spoke to **Bacong Police Chief Tingson** requesting assistance based on Article 211. He declined to verify the law and reiterated the incorrect “tender-age” view.
- In **mid-April**, I visited DSWD Bacong seeking formal notice and a case file before attending further meetings. An agent from Dumaguete confirmed by phone that no case file existed. Yet later that day, I received a two-entry report, backdated, with no documentation on the concealment or persons involved.
- Also in April, Bacong Police returned my email transparency request with a statement that no records involving me or my son existed on file.

These events were not mediated formally, and no copies of any official entries were provided.

In accordance with RA 6713, I respectfully request:

1. Certified copies or summaries of all blotter entries involving the individuals named above;
2. Any reports, memos, or logs involving custody, child welfare, or Barangay/DSWD/police coordination;
3. Any guidance, referrals, or advisory actions taken by Barangay Sacsac in these matters.

If no such records exist, I request a signed certification of non-existence for formal legal inclusion.

#### Legal Basis and Deadline for Response

This request is made pursuant to **Republic Act No. 6713** (Code of Conduct and Ethical Standards for Public Officials and Employees), which mandates that public officials act promptly on all transactions and requests within **15 working days** from receipt. This timeframe is further reflected in the spirit of **Executive Order No. 2, s. 2016 (Freedom of Information)**, which has been adopted in practice by many local government units.

Failure to respond within the prescribed period will be formally documented and submitted to appropriate oversight agencies as a denial of access or non-performance of official duty.
